This puppy is sold on Full Registration in which it will be eligible for all registry events and offspring will be eligible for registration.

Puppy is guaranteed to be a purebred. MN Whispering Pines Springer's will either give Registration Papers immediately if bought with full registration or after the spaying/neutering is done. All fees, including sale price, are payable prior to shipment of the animal. Once the puppy leaves the sellers hands to board plane or any other form of transport into the new owner's hands, the Seller holds no responsibility for the puppy.
